This module covers the technical, regulatory and accounting aspects of changes in capital, acquisitions & realizations, and takeover code. The module also covers planning for M&A, best practices in dealing with related parties transactions and interested person transactions.

Course outline

1. In the changes in capital, the participants will examine the pros and cons of share placement, rights issues, convertible instruments, bonus issues, issuance of warrants, capitalization and subdivision, share schemes, scrip dividend scheme and share buyback scheme.
2. The participants will be taught how to plan for an M&A and understand the rules in Chapter 10 of the Listing Manual and the Singapore Takeover Code.
3. The participants will look into best practices and current governance in dealing with related parties transactions. In particular, the participants will examine Chapter 9 Interested Person Transactions and IFRS on the measurement and disclosures of related parties transactions
